ESSCA MEMBERSHIP IS NOW FREE!

The recent change to the ESSCA Constitution approved by membership

means mandatory payment of dues is no longer a requirement for ESSCA membership. Because we will continue to be a membership-based organization folks will need to register each year to be considered active members. All other aspects of membership will remain the same:

- · An active membership in ESSCA entitles all adults aged 18 years and older residing in the ESSCA neighborhood a vote in ESSCA elections and on special issues that may arise from time to time.
- · Membership is not required to attend meetings, receive ESSCA communications and notices or to participate in ESSCA-sponsored events and programs.

You can join ESSCA by <u>visiting our Join Us</u> <u>page</u> (those who joined in September are already current members; all other members should sign up now). Once you sign up and are approved, you'll automatically get a free membership that will last one year from your first login. We'll send you a reminder when your membership needs to be renewed.

While there is no cost for ESSCA membership, we welcome modest contributions to cover our expenses for in-person and virtual meetings, printed and

email communications, website maintenance and fun programs like ESSCAfest. The suggested contribution is \$10 per household per year but any amount is welcome.

REPORT FROM OUR SEPTEMBER 2021 MEETING

At our September meeting we heard from the development team behind 713-719 Sligo Avenue, which revealed their latest design for a building that would have 98 one, two, and three-bedroom apartments for low-income households. Their next step is getting a zoning text amendment (see below in Planning Notes)

Hannah McCann, ESSCA's voting tabulator (Thanks, Hannah!), presented results of the two constitution/by-laws amendments. A two-thirds majority is required to pass amendments.

Question 1: Should any current member be allowed to hold an ESSCA Board position, regardless of length of membership?

For: 72 (63%) Against: 42 (27%)

The amendment did not pass and the membership length requirement is retained.

Question 2: Should membership in ESSCA be free?

For: 85 (75%) Against: 29 (25%)

The amendment passed. Membership in ESSCA is now free!

PLANNING NOTES

Last month, county planners presented their recommendations for the Silver Spring Downtown Plan, which would guide how the area grows and changes over the next 20 years. Some of their recommendations include: redeveloping existing parking garages to provide homes, open space, and some parking; encouraging small-scale retail; allowing duplexes, triplexes, and fourplexes between Fenton and Grove streets where some already exist today; and creating more places to walk and bike safely.

In other news: Earlier this month, the Montgomery County Planning Board reviewed zoning text amendment 21-07, that

would allow all-affordable housing developments to be a little bigger and taller than otherwise allowed in that area. One of the sites this would impact is 713-719 Sligo Avenue, which today could not be built as tall as the 6-story apartment buildings next door and across the street. The Planning Board recommended that the County Council vote to approve it.
