NOVEMBER ESSCA MEETING: WHAT'S YOUR VISION FOR DOWNTOWN AND EAST SILVER SPRING IN 20 YEARS?

County Planners will be our special guest and will give us an update on the <u>Downtown Silver Spring and Adjacent Communities Plan</u> and what they've heard from the community so far. There will be time for questions and answers and time to tell the Planners what you like about Downtown and East Silver Spring, what you don't like and what a successful plan looks like. We would especially like to hear from renters in the neighborhood. Can't make the meeting? You can also take the County's Listening <u>Survey</u> any time.

FENTON STREET MEETING

On Wednesday, Nov. 18th at 7:00 PM the County DOT will hold a virtual meeting for the Fenton Street Bikeway Study and the Fenton - MD 410 intersection. Advanced registration is required to attend.

GROVE STREET NEIGHBORHOOD GREENWAY PILOT PROJECT

On September 29th the County Department of Transportation (DOT) conducted a community meeting to report its initial recommendations for traffic measures for Grove Street. Plans will include a dedicated walking lane on the west side of the street. Treatments should be in place and the street reopened within the coming weeks. One issue with the walking lane is that it would be considered a sidewalk and snow removal will need to be handled by adjacent property owners. A few meeting attendees reiterated the importance of focusing efforts on walkers and bikers and it was strongly suggested that the County make counts of walkers, bikers and rollers to measure the increase in usage/level of comfort for these travelers and not just focus solely on vehicle speed and volume metrics. Please see the county-written Neighborhood Greenway primer for more information on the concept as well as more information on some of the measures typically employed to calm vehicular traffic. As a reminder, this is considered a pilot project; the measures to be installed will be done so on a temporary basis to allow for review, assessment and some degree of experimentation to achieve the right blend of safety and convenience for walkers, bikers and vehicles. Additional opportunities for feedback and input will be available in the

future. We look forward to work starting to make Grove Street safer and more welcoming for everyone.

ARTSPACE UPDATE

Construction work on the artist studios and apartments is nearing completion and rental applications are now being accepted for live/work units. You can apply by visiting Artspace Silver Spring Arts Campus Artspace. Artists are encouraged to submit an application even if they do not have all of the documentation required or if they are not sure they qualify. Artspace will work through these issues once they receive an application. Also, some units are reserved for veterans with special pricing. For those interested in commercial studio space, the design and pricing information have been pushed back and will not be available until winter/early spring of 2021. Also included in the complex are 11 for sale townhouses facing Grove Street. Seven of these will be market rate and four will be affordable. While they just started building them last month, they will be going on the market soon. If you are interested in purchasing, please contact Compass Real Estate at 703-822-7400. Compass is working with the County on these sales, so they should have information on the process for purchasing the affordable townhouses.

PURPLE LINE UPDATE

Over the summer the contractor building the Purple Line filed a claim with the State for cost overruns. The parties have been unable to reach a compromise and construction has mostly come to a stand-still, though utility relocation and fabrication of the light rail cars are continuing. We understand the State is looking for another partner to finish the construction and they expect the search and negotiation to take approximately 6 months. In the meantime, the State has approved \$2 million to assist businesses along the route that are affected but those funds have not yet been released. The 16 mile east-west light rail line will connect New Carrollton in Prince George's County and Bethesda in Montgomery County with 21 stops including connections to the Red. Green and Orange Metro lines, as well as MARC, Amtrak and local bus lines. When work resumes it will likely take another 3 years to complete. More information is available at www.purplelinemd.com.
